This contract is for placing a Reservation Fee on a Boxwood Doodles, L.L.C. Bernedoodle Puppy. After carefully reading each section please initial to signify that you have read, understand, and agree to each part of this agreement. - Non-Refundable Reservation Fee. I understand and agree that my \$300 Reservation Fee is non-refundable. All circumstances, including but not limited to if BUYER decides s/he does not want or is no longer able to take the puppy. Upon receipt of the Reservation Fee, BREEDER agrees to hold the puppy for BUYER until it has been weaned and is ready for pick up. The Reservation Fee shall be made in US Dollars and paid to BREEDER via payments through Zelle, Venmo (sent family & friends), PayPal (sent family & friends or invoiced with a 3.5% fee), Personal Check or Cashiers Check sent Certified Mail, or cash and must be received within 5 business days.
- BUYER Acknowledgements. BUYER further acknowledges and agrees that (a) BREEDER cannot control litter sizes and that the wait time for puppies can be longer than expected; (b) the Reservation gives BUYER a “Selection” place, but does not guarantee a puppy or that BUYER’s preferences will be available

when it is BUYER's turn to pick; (c) Selections are given on a first-come first served basis and BUYER's place in line is not negotiable. The waitlist is kept up to date on the website; (d) BREEDER cannot and does not guarantee any specific qualities of the puppy when it becomes an adult; (e) BREEDER reserves the first 2 selections of every litter. BREEDER may, in its sole discretion decide to pick or forfeit their 1 or 2 selections; (f) BUYER acknowledges selections are available once breeder has chosen to select or pass.

3. **BUYER's Right to Transfer/Refund.** Notwithstanding the foregoing, if a puppy that meets BUYER's identified preferences is not available when it becomes BUYER's turn to pick a puppy from the selected litter, BUYER may elect to have the Reservation transferred to the next litter. The Reservation Fee cannot be transferred to friends, family, or acquaintances and said reservation fee will only apply toward the person who initially put the reservation fee down.
4. **Refund at BREEDER's Discretion.** If BUYER pays the Reservation Fee, then later decides s/he does not want the puppy for any reason, BREEDER is not required to refund the Reservation. If the BREEDER, should decide, for any reason, to act on their right of refusal to sell a puppy to the BUYER, the BUYER's Reservation Fee would be fully refunded.
5. **BUYERS Obligations.** BUYER hereby agrees to read, understand, accept, and sign ALL contracts pertaining to the sale prior to puppy leaving the premises. (a.) The Bill of Sale Contract will be given to BUYER at the time the Reservation Fee Contract is given for BUYER to read prior to placing a Reservation Fee; (b.) BUYER agrees to make traveling accommodations to pick up puppy in Choudrant, Louisiana.
6. **Final Purchase Price.** BREEDER and BUYER agree that (a) the Reservation shall be applied to the final purchase price of the puppy and (b) the remaining balance will become due when puppy is 6 weeks old if paying electronically or by check OR may pay in cash on the day of pick up. (c) The Bill of Sale contract will be signed and sent when puppy is 6 weeks old regardless of payment method. Should BUYER fail to complete purchase for any reason, BUYER will forfeit Reservation Fee. The total purchase price for the puppy is dependent on size and color and ranges from \$ 2750 to \$ 5500 . The foregoing purchase price does not include any delivery or shipping charges nor breeding rights. Puppy must be picked up before the 9<sup>th</sup> week of age and spayed or neutered by 12months of age.
7. **Governing Law.** This Agreement, and all matters arising out of or relating to this Agreement, shall be governed by, and construed in accordance with the laws of the State of Louisiana within Lincoln Parish without regard to the conflicts of law's provisions thereof.
